Course Description

Finite mathematics with applications to business, biology, and the social sciences. Linear functions and inequalities, matrix algebra, linear programming, and financial math. Emphasis on setting up mathematical models from stated problems.

Prerequisites

MA 109 or equivalent

Student Learning Outcomes

This course will emphasize computational and modeling aspects of mathematics. The course will also require you to effectively communicate your solutions. This means that by the end of the semester you should be able to: setup application or word problems, explain the result of a computation, interpret formulas or processes, and clearly communicate your solution process, in addition to getting the "right" answer.

The web homework is only capable of testing your computational ability. Lecture, recommended readings, and other provided materials will help develop your modeling and mathematical communication skills.

Required Materials

Course Text: The course text is Applied Finite Mathematics by Sekhon and is free for download under the files tab in this Canvas shell or can be downloaded for free here (Links to an external site.)Links to an external site.. If you want a hard copy, you will need to print the book. You only need to print chapters 1-10. The rest of the material in the book will not be covered in this course.

Calculator: You will need a calculator to perform certain calculations on exams. Scientific calculators (like the TI-30X) or business calculators (like the BA-II) will be adequate. Graphing calculators are allowed but they are not required. However, exam questions will be written to ensure that students with graphing calculators do not have an unfair advantage. Exam proctors reserve the right to clear the memory of any calculator you bring into the exam room. Note that you will never be allowed to use the calculator on a cell phone, or any other communication device. Alternates, Makeups and Extensions

WeBWork: NO HOMEWORK EXTENSIONS will be individually given. There are extra problems incorporated into the grading to make up for a couple missed homework assignments. All of the homework assignments are open at the beginning of the semester. If you know you will not be available to complete homework, plan ahead and complete them before the deadline. Extreme situations will be considered on a case by case basis.

Exams: Alternate exams can be requested by filling out the alternate exam request form in the case of a course conflict or official university event. According to university policy, it is the student's responsibility to resolve scheduling conflicts with common hour exams, and this must be done at least TWO WEEKS before the exam. If you fail to inform your instructor of exam conflicts in timely manner, a penalty may be assessed on your exam score. To avoid any problems, request alternate exams as soon as you know you

may have a conflict.

Excused Absences

Senate Rules 5.2.4.2 defines the following as acceptable reasons for excused absences: (a) serious illness, (b) illness or death of family member, (c) University-related trips, (d) major religious holidays, and (e) other circumstances found to fit reasonable cause for nonattendance by the professor.

Students anticipating an absence for a major religious holiday are responsible for notifying the instructor in writing of anticipated absences due to their observance of such holidays no later than the last day in the semester to add a class. Two weeks prior to the absence is reasonable, but should not be given any later.

Students are expected to withdraw from the class if more than 20% of the classes scheduled for the semester are missed (excused) per University policy.

Per Senate Rule 5.2.4.2, students missing any graded work due to an excused absence are responsible: for informing the Instructor of Record about their excused absence within one week following the period of the excused absence (except where prior notification is required); and for making up the missed work. The professor must give the student an opportunity to make up the work and/or the exams missed due to an excused absence, and shall do so, if feasible, during the semester in which the absence occurred.

Dead Week Classes continue as usual. Homework is due and the typical measures of in-class participation will be present. No papers or exams will be given during dead week.

Academic Integrity
