Course Description: The ideas and methods of linear algebra are used throughout all fields of mathematics and most other sciences. The central objects of study in linear algebra are vector spaces and linear maps. This course will introduce these objects from a more abstract perspective than one usually sees in an undergraduate course on the subject.

Required Materials: *Linear Algebra Done Right* by Sheldon Axler, Springer-Verlag, 4nd edition. A PDF version is available for free from the publisher at <https://linear.axler.net/>

Homework: There will be homework assigned every Friday, posted on the class website, due the following Friday. It is fine to discuss the homework together, but you must write up your own solutions in your own words. Your solutions should be written in full sentences and be grammatically correct. Homework may be either hand-written or texed, but **if you type your homework, you must use tex.**

Exams: There will be one midterm and one final exam. The midterm will be in class on 10/18.

Grading: Your course score will be based on the following percentages:

40% Homework

30% Midterm

30% Final

In cases where students feel unsure about the question of plagiarism involving their own work, they are obliged to consult their instructors on the matter before submission.

When students submit work purporting to be their own, but which in any way borrows ideas, organization, wording or anything else from another source without appropriate acknowledgment of the fact, the students are guilty of plagiarism. Plagiarism includes reproducing someone else's work, whether it be a published article, chapter of a book, a paper from a friend or some file, or something similar to this. Plagiarism also includes the practice of employing or allowing another person to alter or revise the work which a student submits as his/her own, whoever that other person may be.

Students may discuss assignments among themselves or with an instructor or tutor, but when the actual work is done, it must be done by the student, and the student alone. When a student's assignment involves research in outside sources of information, the student must carefully acknowledge exactly what, where and how he/she employed them. If the words of someone else are used, the student must put quotation marks around the passage in question and add an appropriate indication of its origin. Making simple changes while leaving the organization, content and phraseology intact is plagiaristic. However, nothing in these Rules shall apply to those ideas which are so generally and freely circulated as to be a part of the public domain (Section 6.3.1).

Please note: Any assignment you turn in may be submitted to an electronic database to check for plagiarism.
